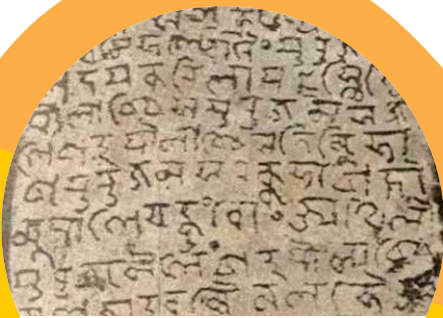

Accountant General, Odisha

Context:

- A preliminary audit by the Accountant General (AG), Odisha found serious problems in collecting Annual Lease Rental (ALR) from private agencies.
- These agencies are running seven tourism properties under the Public-Private Partnership (PPP) model.

Annual Lease Rental (ALR)

Annual Lease Rental (ALR) refers to the total amount of rent payable annually for a leased property or asset. It's the yearly cost a lessee (the party renting) pays to the lessor (the property owner).

Key Findings by Accountant General:

- Around ₹3.24 crore in ALR dues have not been paid for many years by these agencies.
- As per rules, private agencies must pay ALR in advance every year and if delayed, they must pay 18% penalty interest.
- But the Tourism Department didn't send demand notices to all agencies, as required.
- Also, no action has been taken to end the lease agreements, even though some leases started in 2016 and dues remain unpaid.
- This shows poor monitoring and lack of enforcement by the department, leading to loss of public money.

Who is the Accountant General (AG)?

- Every state has an Accountant General (AG) or Principal Accountant General (PAG) under the Comptroller & Auditor General (C&AG) of India.
- The C&AG is a Constitutional Authority, appointed by the President of India.
- The AG checks state government departments, public sector units and autonomous bodies.
- The AG works under Articles 149 to 151 of the Indian Constitution and the C&AG's Duties, Powers and Conditions of Service Act, 1971.
- The AG prepares the state's Finance and Appropriation Accounts and submits them to the Governor, who then presents them in the State Legislature.

- The AG helps ensure transparency, accountability and financial discipline in how the state handles public money.

NOTE: The current Accountant General (Audit-II) of Odisha is Shri Atul Prakash. He assumed the charge on January 6, 2025

Odisha yet to finalise PESA Rules for Scheduled Areas Implementation

Context:

- The Panchayats (Extension to Scheduled Areas) Act (PESA), 1996 empowers Gram Sabhas in Scheduled Areas to manage natural resources and ensure self-governance.
- However, Odisha is yet to notify the PESA Rules essential for implementing this Act across its Fifth Schedule (tribal-dominated) districts.

Details

- Odisha Government has not set a timeline for final notification of PESA Rules.
- A draft notification was issued on November 10, 2023, seeking public feedback.
- Consultations and personal hearings were held with stakeholders.
- Draft rules were translated into Odia and Santhali for wider accessibility.
- Rules were modified post-feedback and shared with departments for review.
- The process is ongoing; final notification is still awaited.
- PESA applies to Fifth Schedule areas like Malkangiri, Koraput, Rayagada, Nabarangpur, Sundargarh, Mayurbhanj and parts of other tribal-dominated districts.

What is the PESA Act, 1996?

- PESA = Provisions of the Panchayats (Extension to Scheduled Areas) Act.
- Extends Part IX of the Constitution (Panchayats) to Fifth Schedule areas with modifications.

Need for PESA

- 73rd Amendment excluded Fifth Schedule Areas from Panchayat provisions.
- PESA bridges this gap, recognizing tribal customs, self-rule and decentralised governance.

Objectives

- Enable self-governance for tribal communities.

- Make **Gram Sabha** central to village-level planning and decisions.
- Protect **tribal customs, resources and identity**.

Applicability

- Applies to **10 states**: AP, Telangana, Chhattisgarh, Gujarat, HP, Jharkhand, MP, Maharashtra, Odisha, Rajasthan.
- Covers only **Fifth Schedule Areas**.

Key Features

- Laws must align with **tribal customs** and traditions.
- **Gram Sabha** empowered to approve plans, certify fund use and manage resources.
- **Mandatory consultation** for land acquisition, mining and displacement.
- Control over **minor forest produce, markets, money lending and social sectors**.
- **50%+ reservation** for STs in Panchayats; all chairperson seats reserved for STs.

Significance

- Empowers tribals with **local decision-making**.
- Protects **land, forests and water** (Jal, Jungle, Jameen).
- Promotes **sustainable development and inclusive governance**.
- Legally recognizes **tribal institutions and dispute resolution systems**.

Similipal Tiger Reserve

Context

- Odisha's Forest Department plans to introduce **male tigers** into **Similipal Tiger Reserve (STR)** to boost **natural breeding and in-situ conservation**.

About Similipal Tiger Reserve (STR)

- Located in **Mayurbhanj district**, Odisha; covers **2,750 sq km**.
- Part of **Mayurbhanj Elephant Reserve**, including **Hadgarh and Kuldiha Wildlife Sanctuaries**.
- Named after the **Simuli (red silk cotton) tree**.
- Declared a **tiger reserve** in 1973 under **Project Tiger**.
- Also, a **UNESCO Biosphere Reserve** since 2009.

Geography & Ecosystem

- Rich in biodiversity with **tropical moist deciduous forests**, sal trees, grasslands and over **1,000 plant species**.
- Major rivers: **Budhabalanga, Kharkai, Palpala, Deo**.
- Home to animals like **tigers, elephants, leopards, sambar deer, gaurs and four-horned antelope**.
- Has beautiful **waterfalls**: **Barehipani (217 m)** and **Joranda (181 m)**.

- Divided into **Southern (core, hilly)** and **Northern (tourist spots)** zones.
- Wildlife also includes **242 bird species** and **30 types of reptiles**, including **mugger crocodiles**.

Challenges & Conservation Efforts

- Core villages like **Kabatghai** and **Bakua** remain; relocation efforts are ongoing but controversial.
- Issues like **cerebral malaria** pose health risks in the area.
- Faced major **forest fires in 2021**, causing wildlife displacement.
- Vegetation studies show **human disturbances** in buffer zones, but potential for **ecological recovery** with proper protection.

Debrigarh Wildlife Sanctuary

Context

- The Odisha government is planning to introduce tigers in **Debrigarh Wildlife Sanctuary**.

Debrigarh Wildlife Sanctuary

- **Debrigarh Wildlife Sanctuary** is located in **Bargarh district**, near **Hirakud Dam** in **Sambalpur**.
- Spread over **346.91 sq. km**, this sanctuary is recognised for its rich biodiversity and has been declared an **Eco-Sensitive Zone**, restricting industrial activities to protect its ecological integrity.

Geographical and Ecological Features

- Surrounded by the **Hirakud Reservoir** on the east and north.
- Supports both **terrestrial and aquatic biodiversity**, making it unique in Odisha.
- A major wintering ground for **migratory waterfowl**.

Flora and Fauna

- Hosts over **250 plant species**, many with **medicinal and ethno-botanical value**.
- Houses **40+ species of mammals**, **200+ birds**, **40 reptiles**, **12 amphibians**, **42 fish**, **39 odonates**, **85 butterflies** and **38 spiders**.
- Key species include **cheetal, sambar deer, wild boar, gaur, chowsingha, Indian wild dog, leopard, bear, langur and peacock**.

Baitarani River

Context:

- **Baitarani River** crossed the alert level near **Akhuapada in Bhadrak district**, raising fears of another flood.

About Baitarani River:

- **Location:** Flows mainly through Odisha, with a small stretch in Jharkhand.
- **Length:** 360 km, ending in the Bay of Bengal near Chandabali.
- **Source:** Originates from Gonasika Hills (Guptaganga) in Keonjhar, Odisha. The river initially flows underground for about 0.5 km.
- **Course:** Flows north for 80 km, then turns east at Anandapur, forming a deltaic zone near Akhuapada.

Tributaries and Basin:

- Has 65 tributaries (35 left, 30 right); major ones include Budhi, Kanjori, Ambajhara, Mushal, Kusei and Salandi.
- Covers 42 blocks in 8 Odisha districts, part of the state's Central Plateau.

Dams and Irrigation:

- Dams and barrages (e.g., at Singhanali and Anandapur) help irrigate 61,920 hectares.
- Future projects like Bhimkund and Upper Baitarani aim to increase irrigation coverage to over 1,000 sq km.

Flooding Concerns:

- Flooding is frequent, especially during monsoon.
- Notable flood: In July 2005, after just two days of rain, 140,000 people in 220 villages (Jajpur & Bhadrak) were affected.
- Weak embankments, delayed dam projects and poor upstream land use planning add to the risk.

Water Quality and Industry:

- Near the river mouth, water turns salty.
- Rapid industrial, mining and agricultural development in the basin has led to pollution and water quality decline.

Odisha launches AWESOME App

Context:

- The Anganwadi Welfare and Service Oversight Monitoring Everywhere (AWESOME) app was launched to digitally monitor infrastructure and service delivery at anganwadi centres.

Details

- The AWESOME App aims to improve transparency, ensure accountability and strengthen the quality of services provided under the Integrated Child Development Services (ICDS) scheme.
- The App will digitally monitor infrastructure and service delivery at anganwadi centres.
- **Odisha's Vision 2036:** The state aims to become malnutrition-free by 2036 through empowerment of frontline workers and communities.

Bank Credit Rising in Rural and Tribal Odisha: Centre

Context:

- Union Minister of State for Finance informed the Rajya Sabha that bank credit in Odisha has been growing steadily, especially in tribal districts, over the past three years.

Key Highlights:

- **CAGR of bank credit in Odisha** (last 3 years): 11.41%
- **Growth in tribal districts:**
 - Kandhamal: 8.28%
 - Koraput: 11.79%
 - Malkangiri: 14.25%
- **Credit deployment** follows the Annual Credit Plan (ACP), based on NABARD's Potential Linked Credit Plan (PLP).
- **Cumulative ACP achievement** over 3 years:
 - Malkangiri: 94%
 - Koraput: 93%
 - Kandhamal: 92%
- **Measures to improve credit flow:**
 - Credit outreach programmes and financial literacy camps
 - Business Correspondents (BCs) and Customer Service Points (CSPs) in tribal clusters
 - Strengthened monitoring via DCCs and DLRCs
- **Improved banking infrastructure:**
 - **Kandhamal:** BCs rose from 351 to 701; ATMs from 76 to 88
 - **Koraput:** BCs from 464 to 1,018; bank branches from 135 to 148
 - **Malkangiri:** BCs from 325 to 559
- **CD Ratio** in tribal areas monitored quarterly by SLBC with necessary directives to banks.

Note: NBFC credit to GDP ratio rose to 26% in FY25, surpassing bank credit growth.

Odisha makes She-Box Portal mandatory in Higher Education Institutions

Context:

- Following the suicide of a student at FM College, the Odisha Higher Education Department has mandated all higher education institutions and department-level offices to use the She-Box portal for reporting harassment cases.

Details:

- **Mandate:** All institutions must upload:
 - Details of Internal Complaints Committee (ICC).

- Details of **Local Committee** (if applicable).
- Number of **harassment complaints** received under the **Sexual Harassment of Women at Workplace Act, 2013**.
- **Status of complaints resolved**.
- **Deadline:** All data must be uploaded by **August 1, 2025**.
- **Purpose:**
 - Improve **transparency** and **accountability**.
 - Strengthen implementation of **gender-safety norms**.
 - Respond to public concern after the FM College incident.
- The move seeks to ensure a **safe and responsive environment** for **women students and staff** across Odisha.

She-Box Portal

- **She-Box** is an online platform developed by the **Union Ministry of Women and Child Development** for lodging complaints of **sexual harassment** at workplaces and institutions.
- **Launched by:** Ministry of Women and Child Development
- **Purpose:** To **strengthen implementation** of the **Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013**

Features:

- Ensures **confidentiality**-- only the **Chairperson of Internal Committee (IC)** or **Local Committee (LC)** can access complainant details.
- **Accessible filing**-- women or their representatives can file complaints online with basic details (name, phone number, email, work status).
- If the IC/LC is registered, complaints are **automatically forwarded** to them.
- Includes a **monitoring dashboard** for **nodal officers** to track complaints (filed, resolved, pending).
- **Timeline:** The Act mandates **90 days** for inquiry.

Odisha tops India in Sickle Cell Cases

Context

- Odisha has the **highest number of sickle cell patients in India** with **96,080 cases**, as per data shared in the **Rajya Sabha** by **Anupriya Patel**, Minister of State for Health and Family Welfare.

Details

The total registered sickle cell patients across India is **2,15,380**.

Other states with high numbers:

- **Madhya Pradesh:** 30,580
- **Gujarat:** 28,150

- **Chhattisgarh:** 26,104
- **Maharashtra:** 23,218

Sickle Cell Anaemia

- Sickle Cell Anaemia is a genetic blood disorder predominantly affecting tribal and vulnerable populations in India. The Government of India has been actively implementing screening and awareness programmes under the **National Health Mission (NHM)** and other scientific bodies.

National Sickle Cell Anaemia Elimination Mission (NSCEM)

- **Launch Date:** 1 July 2023, Shahdol, Madhya Pradesh
- **Goal:** Eliminate sickle cell anaemia by 2047

Key Features

- **Target:** Screen **7 crore people** under **40 years** in **3 years (2023–26)**
- **Focus:** Tribal communities, high-burden areas
- **Coverage:** **17 high-focus states** incl. Odisha, MP, Chhattisgarh, Maharashtra, Gujarat, Jharkhand
- **Implementation:** Under **National Health Mission (NHM)**

Components

- **Genetic Screening:** For early detection
- **Sickle Cell Genetic Status Cards:** Issued to help avoid high-risk marriages
- **Awareness Modules:** For healthcare workers, teachers, parents and patients
- **Training Modules:** For medical staff at all levels
- **Counselling:** For patients and families

Shaktishree Scheme

Context

- Odisha launched 'Shaktishree', a state-wide initiative to ensure the safety, security and empowerment of women in universities and colleges.

Details

- 'Shaktishree' is a **state-wide programme** for the **safety, security and empowerment of women** in higher education institutions.
- This state-wide programme targets all **state universities** and **government/aided colleges**, covering **over 730 institutions**.
- It aims to ensure **safe, respectful and empowering spaces** for female students and staff.

Key Features of the 'Shaktishree' Initiative

- **Empowerment Cells in Every Institution.** Each college/university will set up a **Shaktishree Empowerment Cell**, coordinated by a **female faculty** and a **female student leader**. These cells

will promote **self-defence training, emotional well-being and gender sensitivity** among students.

- **District-Level Mentors - Shakti Apas.** Every district will appoint **five senior women professionals** called **Shakti Apas**, who will act as **mentors**, regularly visiting campuses (once every three months) and providing guidance to students.
- **Anonymous Complaint Mechanism via Mobile App.** A **dedicated mobile application** will allow female students to **anonymously report** incidents of harassment through **text, voice, or video**. The app also integrates **mental health support**, linked with the **Tele-MANAS** portal for counselling services.
- **Mandatory Training and Staff Sensitisation.** All teaching and non-teaching staff will undergo **annual online training** on:
 - The **POSH Act, 2013**
 - **UGC (Prevention of Sexual Harassment) Regulations, 2015**
 Institutions will enforce a **code of professional conduct** focusing on **gender sensitivity**.
- **Biannual SAFE Campaign.** The **Shaktishree Actions for Female Empowerment (SAFE)** campaign will be held twice a year to raise awareness about **gender issues, bullying and harassment**.
- **Campus Monitoring and Reporting**
 - Campuses will be equipped with **24x7 CCTV surveillance**.
 - Each institution must submit a **Campus Safety Report** by **December 31** every year.
- **State-Level Meet - Shakti Swarupini.** An **annual gathering** named '**Shakti Swarupini**' will be organised for coordinators of **Shaktishree Cells** to **share feedback, undergo advanced training and review progress**.

Anticipatory Bail

Context

- **Orissa High Court** dismissed the anticipatory bail application filed by **senior IAS officer Bishnupada Sethi** in connection with an alleged **Rs 10 lakh bribery case** being probed by the **CBI**.

What is Anticipatory Bail under Indian Law?

- Anticipatory bail is a legal provision under **Section 438(1) of the Criminal Procedure Code (CrPC)**, which allows a person to seek **bail in anticipation of arrest** for a **non-bailable offence**.
- This provision was introduced following the **recommendation of the 41st Law Commission**

Report, enabling courts to grant protection before an arrest is made.

Who Can Grant Anticipatory Bail?

- Only the **High Court** or the **Court of Session** has the authority to grant anticipatory bail.

When Can a Person Apply for Anticipatory Bail?

A person can approach the court if they believe:

- They may be arrested **on false or fabricated charges**.
- The arrest could be motivated by **personal enmity or vendetta**.
- There's a **real apprehension** of being framed in a criminal case.

Conditions Imposed by the Court

The court may grant anticipatory bail with certain conditions, such as:

- The person must be **available for police interrogation** when required.
- They must not **influence or threaten witnesses**.
- They should not **leave the country without the court's permission**.

What Happens After Arrest (If Bail Was Granted)?

- If the person is later arrested and is ready to offer bail, they must be released.
- If the Magistrate decides to issue a warrant, it should be a **bailable warrant**, as per the court's earlier direction.

Important Ruling

- In the **Sidhram Mhetre case**, the **Supreme Court** held that **certain restrictive conditions** imposed by the **High Court** were **unwarranted and contrary** to the intent of anticipatory bail provisions.

Cancellation of Anticipatory Bail

Anticipatory bail **can be cancelled** by the **High Court or Sessions Court**, if:

- The **complainant** or the **prosecution** files an application.
- The court finds that the accused has **violated conditions or misused the liberty** granted.

Important Note

- The applicant must present **specific facts** showing the likelihood of arrest for a particular **non-bailable offence**.
- Courts are expected to mention **clearly the offence(s)** for which the bail applies--it **cannot be a blanket protection** for all offences.

Gopabandhu Jana Arogya Yojana

Context

- Since the launch of **Gopabandhu Jana Arogya Yojana**, over **2.6 lakh beneficiaries** have received treatment in Odisha.

Gopabandhu Jan Arogya Yojana (GJAJ) - Odisha's State Health Assurance Scheme

- **Launched in 2017** as **Biju Swasthya Kalyan Yojana (BSKY)** to provide **universal health coverage** to both **BPL and APL families**.
- Renamed as **Gopabandhu Jana Arogya Yojana** after the **2024 Odisha Assembly Elections** and made a subset of **Ayushman Bharat**, impacting its independent identity.
- Offered **free treatment in government hospitals** from sub-centres to district HQs, supported by **Swasthya Mitras**.
- Provided **₹5 lakh per family annually**; **₹7 lakh for female members**, with **₹2000 conveyance** for out-of-state treatment.
- Covered major hospitals like **Tata Memorial, CMC Vellore, Narayana Hrudalaya**.

Phased Expansion

- **First Phase:** Free healthcare in public facilities for **70 lakh families**, covering **70% of population**.

Subhadra Yojana

Context

- The Odisha government will reopen the Subhadra Yojana portal after August 9, allowing young women aged 21 and above to newly apply for the financial assistance scheme.

Reassessment and Exclusions

- Around **2 lakh beneficiaries** have been **excluded** for failing to meet **post-disbursal eligibility criteria** such as:
 - Filing **Income Tax Returns**
 - **Vehicle ownership**
 - Owning **5 acres or more of land**

- To address concerns, the government will conduct a **fresh survey** after August 9 to **reassess excluded beneficiaries** and ensure **only eligible women** continue to receive benefits.

Inclusion of New Beneficiaries

- Women who **turn 21 by August 9** will become **eligible to apply**.

Subhadra Yojana

- **Launched:** 2024
- **Aim:** Economic empowerment of **women aged 21-60** from **economically weaker sections** in Odisha.
- **Target:** To benefit over **1 crore women** across the state.

Key Features

- **Assistance Amount:** ₹50,000 over **5 years (2024-2029)**.
- **Disbursement:** ₹10,000 per year in **two instalments of ₹5,000** -- on **Raksha Bandhan** and **International Women's Day**.
- **Eligibility:**
 - Women aged **21-60 years**.
 - **Exclusions:** Govt employees, income-tax payers and women receiving over ₹1,500/month from other schemes.
- **Registration:**
 - Began on **1 September 2024**; over **50 lakh women** registered.
 - **No deadline** for registration.
- **Subhadra Debit Card:** Issued to facilitate seamless fund access.
- **Incentive:** Top **100 women per gram panchayat/urban area** with highest digital transactions get **₹500 extra**.

Implementation Mechanism

- Utilises the **JAM Trinity (Jan Dhan-Aadhaar-Mobile)** for direct benefit transfer.
- **e-KYC** is mandatory.
- As of **17 September 2024**, **₹1,250 crore** disbursed to **25 lakh beneficiaries**.

Special Intensive Revision (SIR) of Electoral Rolls

Context

- Odisha is set to launch a **Special Intensive Revision (SIR)** of its electoral rolls--the first such drive since 2002.

Special Electoral Roll Revision

What is it?

- A **targeted, house-to-house voter list verification** carried out by the Election Commission to remove errors, include new voters and ensure a clean electoral roll.

- Triggered in specific states or areas with known irregularities or high migration.

Constitutional Basis:

- **Article 324:** Empowers the Election Commission to supervise elections.
- **Article 326:** Ensures universal adult suffrage.
- **Representation of the People Act, 1950:** Provides the legal mechanism for electoral roll preparation and revision.

Opportunities:

- Cleans voter list by removing duplicates or deceased entries.
- Encourages first-time voters to register.
- Enhances transparency with digital tools (e.g. blockchain pilot in Bihar).
- Supports smooth conduct of future elections and delimitation.

Challenges:

- Risk of **exclusion of marginalised communities**, especially migrants and the urban poor.
- **Aadhaar-based verification**, though convenient, may lead to wrongful deletions (Aadhaar ≠ citizenship).

- Allegations of **political misuse**--targeted disenfranchisement in opposition states.
- Weak awareness and grievance redressal mechanisms.

Way Forward:

- Use **multiple ID proofs** for verification, not Aadhaar alone.
- Ensure **offline support**, especially for digitally excluded populations.
- Promote **local-level hearings** before final deletions.
- Engage with **civil society** to reach vulnerable groups.

Oldest Odia Inscription discovered

Context

- A **16-line Sanskrit inscription** in Odra Nagari script (the earliest form of Odia writing) has been **deciphered** at **Jeypore Museum, Koraput**.
- It is now considered the **oldest known epigraphic record** from Odisha, **predating the Khechela copper plate**.

Khechela Copper Plate

The Khechela copper plate is a significant historical document from Odisha, India, specifically from the Koraput district. It's a copper plate inscription belonging to the Chindaka Naga dynasty and is considered the earliest known inscription from the Koraput region. This discovery is crucial for understanding the spread of the Chindaka Naga dynasty and sheds light on the evolution of the Odia script, tribal culture and interactions between Odisha and the Bastar region.

Chindaka Nagas

The **Chindaka Nagas** were a medieval dynasty that ruled the region known as **Chakrakota Mandala**, covering present-day **Bastar (Chhattisgarh)**, **Koraput** and **Kalahandi (Odisha)** from around **1023 to 1324 AD**. Believed to be of **Kannada origin** from the **Sindavadi region** (modern Karnataka) they were possibly linked to the **Sinda family of Gulbarga**. Their rule began during or after the **Chola expedition of Rajendra Chola**, with some historians suggesting support from the **Somavamshi rulers** in their establishment. The dynasty, which referred to itself as **Nagavamsi** and claimed descent from the mythical city **Bhogavati**, had **Barasur** as its capital and worshipped **Manikyadevi** as their patron goddess. At their zenith under **King Somesvara**, they engaged in warfare with neighbors such as the **Somavamshis**, **Kalachuris of Ratnapura**, **Telugu Chodas**, **Mana tribe** and **Western Chalukyas**. Somesvara expanded influence into **Dakshina Kosala**, though some claims may have been exaggerated. Over time, they faced invasions by the **Kalachuris**, **Yadavas** and **Kakatiyas**, leading to decline. The dynasty's final ruler was **Harishchandradeva**, mentioned in a **1324 Sati inscription**, marking the end of Chindaka Naga rule.

Content of the Inscription:

- It is a **Sanskrit eulogy** of a **Chindaka Naga king**, titled. "*Madana Nrpa Kula Kamala Bhaskara Tilaka*" (meaning "the sun among the lotus of the Chindaka Naga clan").
- Written in **corrupted Sanskrit**, it reflects early development of the **Odia language**.
- Mentions important words such as "**Bikantha Sri Karana**", "**Kasa Dasa**" and "**Damodara**".

Location and Historical Link:

- The stone pillar likely originated from **Bhairabsinghpur-Kamta-Kumli** in the **Indravati valley**, on the historic frontier of **Odisha and Chakrakota (present-day Bastar, Chhattisgarh)**.
- Associated with the reign of **Someswara Deva (1069-1110 CE)** of the Chindaka Naga dynasty.

Distinctive Features:

- The inscription is accompanied by a **rare erotic motif** of a **donkey and pig**, also seen in other Naga dynasty artefacts.

Significance:

- Offers a crucial link between **Odisha's script evolution, early medieval politics, tribal culture** and its connection with **Bastar**.
- Provides rare linguistic and historical insights into **early Odia identity**.

ODISHA RELATED STATIC GK

landmass of 1759 km². It was formed on April 1, 1993, by carving it out of Cuttack district.

According to the Census 2011, Deogarh district has the lowest population in Odisha.

The Udayagiri Caves in Odisha are known as the "Ellora of Odisha".

Barehipani Falls stands as the tallest waterfall in Odisha.

The Mahanadi River is often called the "Ganga of Odisha".

Talcher is the city in Odisha known as the "Black Diamond City". This nickname is due to its significant coal reserves and mining industry. It's located in the Angul district.

The second largest river in Odisha is the Brahmani River. It's formed by the confluence of the Sankh and South Koel rivers. The river flows through several districts of Odisha, including Sundargarh, Deogarh, Angul, Dhenkanal, Cuttack, Jajapur, and Kendrapara.

The name Odisha is derived from the ancient kingdom of Odra,

which was inhabited by the Odra tribe.

Elections to the Orissa Legislative Assembly held on 27 March 1952 were the first assembly elections in Orissa.

The last independent Hindu king of Odisha was Mukunda Deva, also known as Mukunda Harichandana. He ruled from 1559 to 1568 AD and belonged to the Chalukya dynasty.

Odisha was established as a state on April 1, 1936. It was formed by carving out portions from the Bihar and Orissa Province and the Madras Presidency.

The first Odia magazine was Bodha Dayini, published in 1861 in Balasore.

Fakir Mohan Senapati is widely regarded as the father of modern Odia literature.

The Kandha (or Kondh) tribe is the largest tribal group in Odisha.

Dr. Pratibha Ray is widely recognized as the "Queen of Odia literature".

Shri Saswata Mishra is the principal secretary Finance in Odisha.

The current chairman of the Odisha Public Service Commission (OPSC) is Arun Kumar Sarangi, a retired IPS officer. He was appointed to the position in September 2024.

Seeta Bibaha (1936) was the first Oriya film directed by Mohan Sundar Deb Goswami; it presented the marriage of Lord Rama to Sita, based on the epic story Ramayana.

The first Odia color movie was "Gapa Hele Bi Sata". It was released in 1976 and directed by Nagen Roy. The movie stars Harish Mohapatra and Banaja Mohanty.

The highest honor in Odia cinema is the Mohan Sundar Dev Goswami Award, also known as the Jayadev Award.

In 2024-25, Odisha's per capita income is estimated to be ₹1,82,548

Odisha leads the Fiscal Health Index 2025 with a top score of 67.8, excelling in the Debt Index (99.0) and Debt Sustainability (64.0).

Odisha is the fourth-largest fishproducing state accounting for 6 per cent of total fish

production in India- Economic Survey-2024-25.

Odisha's share of manufacturing has increased in industrial GSVA between 2012-13 and 2024-25.

Odisha's milk production grew by 6.4 per cent in 2023-24 outpacing the national growth rate of 3.8 per cent.

Odisha is the third largest producer of Kendu leaves in the country and this industry generates an annual employment of about 100 lakh man days.

Odisha ranks fifth in rice production in India, contributing 8 per cent to the national output.

The poet Upendra Bhanja was given the title "Kabi Samrat," which translates to "Emperor of Poets" in Odia. He was a 17th-century Odia poet and composer of classical Odissi music, known for his poetic works like Baidehisa Bilasa, Labanyabati, and Koti Brahmanda Sundari.

Jhota or Chita is the traditional Oriya art on the floor and walls, very popular in rural areas. It is found in Places like Ulapgarh, Vikramkhola, Yogimath, Manikmada in Odisha.

Ravana Chhaya Rock in Keonjhar, Odisha features rock paintings that resemble a blend of

Mohenjodaro script and Brahmi script.

The largest coal-based power plant in Odisha is the NTPC Talcher Kaniha, with an installed capacity of 3000 MW.

The first Odia mountaineer to scale Mount Everest was Kalpana Dash, who achieved this feat on May 21, 2008.

Odisha has four notified Biodiversity Heritage Sites (BHS): Mandasaru in Kandhamal district, Mahendragiri in Gajapati district, Gandhamardan in Bolangir and Bargarh districts, and Gupteswar Forest in Koraput district.

India's first round-the-clock grain ATM was opened at Mancheswar in Bhubaneswar, Odisha

The district with the highest sex ratio in Odisha is Rayagada, with a ratio of 1051 females per 1000 males according to the 2011 census.

According to the 2011 Census, Khordha district has the highest literacy rate in Odisha. The literacy rate for Khordha is 86.88%.

Narmada Kar (1893-1980), was an editor, writer and the first woman from Odisha in Eastern India, to pass the B.A. examination.

- The traditional percussion instrument of Odissi music is the Mardala. It's a barrel-shaped drum, indigenous to Odisha, and integral to both Odissi dance and music.

Traditional Instruments of Odisha

Tamak – Percussion instrument with animal skin; played with sticks during marriages and festivals.

Mahuri – Traditional wind instrument; considered auspicious; used in folk theatre and Chhau dance.

Gochi Baja – Percussion instrument; played during marriage processions.

Kendera – Ethnic stringed instrument used by Nātha ascetics; often accompanies folk songs (Kendera Gita).

Ghanta – Metallic gong; played by *Ghantuās* during Rath Jatra and temple rituals.

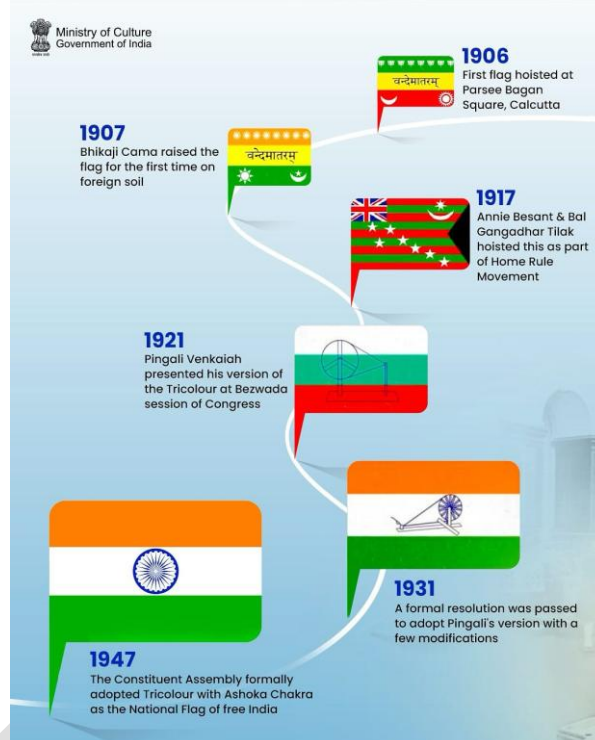

Date	Day/Event
17 June	World Day to Combat Desertification and Drought is observed every year on 17 June , established by the UN General Assembly in 1994 (Resolution A/RES/49/115). It is coordinated by the UN Convention to Combat Desertification (UNCCD) to raise awareness on land degradation and sustainable land use. In 2025, Saudi Arabia hosted the event, highlighting its plan to plant 115 million trees.
20 June	World Refugee Day. Marks the 50th anniversary of the 1951 Refugee Convention . It honours the resilience and courage of refugees who flee conflict and persecution in search of a safer future. Events worldwide celebrate their diverse cultures and aim to promote empathy, inclusion and solidarity.
21 June	World Music Day, International Yoga Day. Aims to recognize the global benefits of yoga for physical, mental and spiritual well-being. It was adopted by the United Nations General Assembly on 11 December 2014 , following a proposal by Prime Minister Narendra Modi during his UN address in September 2014 . The UN resolution titled " International Day of Yoga " was co-sponsored by 177 countries , the highest number of co-sponsors ever for a resolution of its kind. The first Yoga Day was celebrated on 21 June 2015.
23 June	United Nations Public Service Day. Aims to recognize the value and virtue of public service in communities worldwide. Established by UN General Assembly Resolution A/RES/57/277 on December 20, 2002 , the day also features the UN Public Service Awards , which honour outstanding contributions in improving public administration and promoting transparency,



	innovation and citizen-centric governance.
26 June	International Day Against Drug Abuse & Illicit Trafficking. Since 1989 , following a United Nations General Assembly resolution (42/112) adopted in 1987 . The date commemorates Lin Zexu's destruction of opium in China in 1839 , symbolizing the global fight against drug abuse and illegal trafficking. The observance was proposed during the International Conference on Drug Abuse and Illicit Trafficking (Vienna, 17-26 June 1987) , where two landmark texts were adopted to guide future drug control efforts.
1 July	National Doctor's Day. Celebrated annually to honour the contributions of physicians to individuals and communities. In India , it is observed on July 1 to commemorate the birth and death anniversary of Dr. Bidhan Chandra Roy , a renowned physician and the second Chief Minister of West Bengal.
2 July	World Sports Journalists Day 2025. Celebrates the vital role of sports reporters, writers, commentators and photographers in shaping how we experience sports. This year's theme -- "Championing Fair Play: Reporting with Integrity and Impact"
5 July	The International Day of Cooperatives is observed every year on the first Saturday of July to recognize the vital role of cooperatives in promoting economic inclusivity and sustainability . This year's theme -- "Cooperatives: Driving Inclusive and Sustainable Solutions for a Better World" -- highlights their contribution to building a more resilient and equitable global economy .
6 July	World Zoonoses Day. World Zoonoses Day is celebrated on July 6 to raise awareness about diseases in the human-animal interface. More than two-thirds of emerging infectious diseases have their origins in animals. Common examples include rabies, COVID-19, Ebola, bird flu and salmonella.
7 July	World Bioproduct Day , celebrated on July 7 , promotes awareness about sustainable and eco-friendly bioproducts that contribute to climate action and a greener future . First observed in 2021 , the 2025 edition saw global participation, including India , showcasing advancements and goals in the bioeconomy sector .
11 July	World Population Day. It was established in 1989 by the United Nations Development Programme (UNDP) . It was inspired by Five Billion Day (July 11, 1987), the day the global population reached 5 billion , aiming to raise awareness about population issues, reproductive health and sustainable development .
12 July	World Malala Day. It coincides with the birthday of Malala Yousafzai , a Pakistani activist for female education and the youngest Nobel Prize laureate . The day is dedicated to advocating for the right to education for all children, especially girls and honoring Malala's courageous fight for this cause.
15 July	World Youth Skills Day. Raises awareness about the importance of equipping young people with skills for employment, entrepreneurship and personal growth . Marking its 10th anniversary in 2024 (declared by the United Nations in 2014), this year's theme -- "Youth Empowerment Through Artificial Intelligence (AI) and Digital Skills"
17 July	World Day for International Justice. Marks the anniversary of the adoption of the Rome Statute, which led to the formation of the International Criminal Court (ICC) in 1998.
18 July	Nelson Mandela International Day. Nelson Mandela International Day is observed every year on 18 July , marking the birthday of Nelson Mandela . Declared by the United Nations in November 2009 , the day was first celebrated on 18 July 2010 , honouring Mandela's legacy of peace, justice and human rights through acts of community service and global solidarity.
July 20	International Moon Day . Commemorates the Apollo 11 Moon landing in 1969 . Declared by the United Nations General Assembly in 2021 , it promotes peaceful space exploration, global cooperation and the need for sustainable lunar missions .
July 20	World Chess Day. Commemorates the founding of the International Chess Federation (FIDE) in 1924.

28 July	World Nature Conservation Day is observed on July 28 , emphasizing the urgent need to preserve natural resources and protect ecosystems. The 2024 theme , “ Connecting People and Plants, Exploring Digital Innovation in Wildlife Conservation ,” highlights the role of technology in advancing conservation efforts globally.
28 July	It aims raise awareness about hepatitis A, B, C, D and E , which collectively affect millions and cause over 1.34 million deaths annually . The day promotes prevention, diagnosis and treatment of this liver-related disease. It is one of the 11 official global health campaigns by the World Health Organization (WHO) .
22 July	National Flag Day . Indian National Flag was officially adopted on July 22, 1947 by the Constituent Assembly of India , just 24 days before independence (August 15, 1947).

PM WANI (2020) creates public Wi-Fi networks through Public Data Offices.

Sher Shah Suri, founder of the Suri dynasty, introduced the silver coin **Rupiya** weighing 178 grains, standardized weights and measures, defeated **Humayun** at **Chausa (1539)** and **Kannauj (1540)** and built the **Grand Trunk Road** from **Calcutta to Peshawar**.

The **Kalasa-Banduri Nala** project diverts water from **Mahadayi** to **Malaprabha** basin in Karnataka.

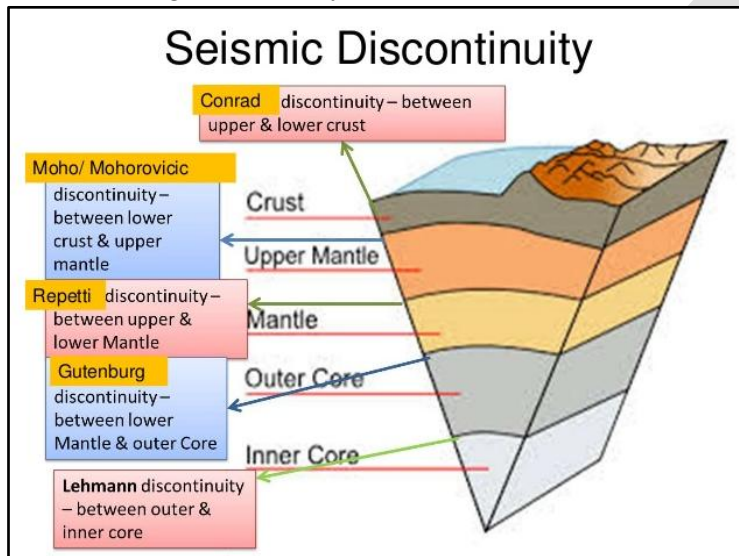
LiDAR mapping is a remote sensing technology that uses laser pulses to generate detailed 3D

models of surfaces by measuring the time it takes for light to bounce back, enabling applications in **topography, forestry, urban planning, coastal mapping, autonomous vehicles, archaeology** and **environmental monitoring**.

The first plant genome to be sequenced was **Arabidopsis thaliana**, a small flowering plant, in 2000.

India's first sodium-cooled fast reactor (PFBR) is being constructed at **Kalpakkam**, Tamil Nadu.

Tanimbar Islands are located in the Indonesian province of **Maluku**, at the end of a long chain of islands that extends from **Sumatra** to **Java**, **Bali**, **Lombok** and down to **Timor**.

Akash is a **Short-Range Surface-to-Air Missile (SAM)** developed by **DRDO** and produced by **Bharat Dynamics Ltd** to intercept

aerial threats up to **25 km** range and **18 km** altitude, guided by **Rajendra PESA** radar.

As of **30 June 2025**, **non-fossil sources** make up **50.08%** of India's **484.8 gigawatt** installed power capacity--meeting the **2030 Paris target five years early**--but contribute only **28-30%** to actual power generation, with **coal** still

supplying around **70%** of the electricity demand.

Behdeinkhlam is a mid-July harvest festival of the **Pnar community** in **Meghalaya**, symbolizing the **driving away of evil** and observed mainly by **Niamtre** followers in **Jowai**.

Klyuchevskoy is an **active stratovolcano** on Russia's **Kamchatka Peninsula** and the **tallest active volcano in Eurasia**, standing at **4,750 meters**, with over **70 side craters** and frequent eruptions since **1700**.

RhoDIS India, launched in **2016** by the **Ministry of Environment, Forests and Climate Change**, uses **DNA indexing** to aid in **rhino conservation and crime investigation**, creating **unique genetic IDs** for individual rhinos.

Noctilucent clouds are **ice-crystal clouds** that form near the **summer polar mesopause** (~80 km altitude), visible only at **astronomical twilight** and known for their **night-shining glow**, typically seen between **50° and 70° latitudes**.

The **Maputo Protocol**, adopted by the **African Union in 2003**, is a landmark treaty promoting **women's rights in Africa**, leading to progress in **political representation**, like in **Rwanda** and improved **reproductive healthcare** across member nations.

Polycyclic Aromatic Hydrocarbons (PAHs) are flat, ring-shaped organic molecules made of carbon and hydrogen, formed on Earth through **incomplete combustion** or **pyrolysis** of organic matter and are known to **persist in oils**, **resist water** and **disintegrate in space** under intense radiation or collisions.

A **pheromone** is a **chemical signal** released by an animal to influence the **behavior or physiology** of other members of the **same species**, such as

triggering mating, alarm, or social behaviors like **locust swarming**.

A person is considered "**ordinarily resident**" in a constituency under **Section 19 and 20 of the Representation of the People Act, 1950** if they habitually live there with the intent of permanent stay, not just casual visits--mere property ownership is not enough and temporary absence doesn't affect this status.

A **second** is officially defined as the time it takes for a **caesium-133 atom** to complete **9,192,631,770 vibrations** during a transition between two energy levels in its ground state.

The **Battery Passport** system is a digital ID for EV batteries, containing key data on **origin, composition, performance, lifecycle** and **supply chain**--all linked via a unique QR code to ensure transparency and traceability.

Japonica rice is a **variety of Oryza sativa**, characterized by **short, round grains that turn sticky and firm when cooked**, due to **low amylose content**. It thrives in cool, temperate climates and is mainly grown in **Japan, China, Korea, Vietnam and Indonesia**.

INS Nistar is an **indigenous Diving Support Vessel** built by **Hindustan Shipyard** to support submarine rescue and deep-sea operations, with **80% local content**. It serves as a mother ship for the **Deep Submergence Rescue Vehicle**, boosting India's self-reliance and IOR maritime capabilities.

Sheesh Mahal, built in the 17th century under **Emperor Shah Jahan**, is a stunning example of **Mughal architecture**, known for its intricate mirror work and placement within a grand **Mughal Garden complex**.

Mount Rainier, the highest peak in Washington (4,392 m), is an **active stratovolcano** with the largest glacier system in the U.S. outside Alaska and is one of the **world's 16 Decade Volcanoes** due to its explosive potential and proximity to Seattle.

Ham radio, or **amateur radio**, is a licensed service that enables individuals to communicate locally, globally and even with space stations using radio waves. In India, those aged **12 years and above** can obtain a license from the **Ministry of Electronics and Information Technology**.

Mount Shinmoedake is an active stratovolcano located in the Kirishima range on Kyushu Island, Japan, standing at **1420.8 meters**.

A **polar anticyclone** is a high-pressure wind system that forms over the **cold polar regions**, especially during winter, due to the **cooling and sinking of dense surface air**. Examples include the **Siberian high** and winter highs over **Canada and Alaska**, which often push cold, dry air toward lower latitudes.

The **Alaknanda River** is a major Himalayan tributary of the **Ganga**, originating from the **Satopanth Glacier** in Uttarakhand. It meets **Bhagirathi** at **Devprayag**, where the river officially becomes the **Ganga**, after confluences with

Nandakini, Pindar and Mandakini at various Prayags.

The **India Energy Stack (IES)** is a **Digital Public Infrastructure** designed for the **energy sector**, offering **secure, standardized and open access** to stakeholders. It aims to digitally integrate the **entire electricity value chain--from generation to consumption.**

The **Financial Fraud Risk Indicator (FRI)** is a tool launched in **May 2025** by the **Digital Intelligence Unit under the Department of Telecommunications.** It assesses the **fraud risk level of mobile numbers--Medium, High, or Very High--and is used by major banks and payment platforms to combat financial fraud.**

Altermagnets are a newly discovered class of magnetic materials that have **no net external magnetism** like antiferromagnets but show **ferromagnet-like electron behavior internally**, making them ideal for advanced technologies like **spintronics.**

The **SPREE Scheme (Scheme to Promote Registration of Employers/Employees),** active from **July 1 to December 31, 2025,** encourages voluntary registration under the **ESI Act,** offering **medical coverage** to left-out workers and compliance benefits to unregistered employers.

India is now free of **Trachoma,** a contagious eye infection caused by the bacterium **Chlamydia trachomatis,** leading to preventable blindness. It spreads through contact with infected secretions and is classified by the

World Health Organization as a **Neglected Tropical Disease.**

Di-Ammonium Phosphate (DAP) is India's second most used fertilizer after urea, vital for early-stage crop growth as it provides **46% phosphorus and 18% nitrogen.**

Kerala renamed **Aralam Wildlife Sanctuary in Kannur as India's first Aralam Butterfly Sanctuary,** home to over 266 butterfly species, representing 80% of Kerala's diversity. Located in the Western Ghats, it protects rare species.

GLP-1 receptor agonist drugs, such as semaglutide and tirzepatide, mimic natural gut hormones that regulate blood sugar and appetite. Now available in India, they offer effective obesity treatment, enabling 15-20% weight loss along with multiple health benefits.

The **Banakacherla Reservoir Project** aims to combat **water scarcity** in drought-prone **Rayalaseema andhra Pradesh,** by linking the **Godavari River** with the **Penna River** through the **Krishna River.** It includes building a new reservoir at **Bollapalli, Guntur district,** with five lift stations, using only **surplus Godavari water.**

The **UN80 Initiative,** launched in **March 2025** by **UN Secretary-General António Guterres,** is a reform agenda aimed at making the **United Nations** more **efficient, effective and relevant** for the 21st century.

The **Rhone Glacier** is the largest glacier in the **Uerner Alps** of

Switzerland and the source of the **Rhone River,** significantly feeding **Lake Geneva** in the canton of **Valais.** The highest point above it is **Dammastock,** standing at **3,630 meters.**

Price Support Scheme (PSS) is a government program that safeguards farmers against market price fluctuations by guaranteeing the purchase of their produce at a predetermined **Minimum Support Price (MSP).**

Digital Payment Intelligence Platform (DPIP) is a centralized system designed to shift fraud management from reactive to proactive by enabling real-time sharing of suspicious account and transaction data among institutions, aiming to prevent financial losses.

The newly identified **EMM-negative blood type,** also called **Gwada negative,** is the rarest blood type globally, with only one known individual as of June 2025. It lacks the **EMM antigen,** a high-incidence antigen normally present on red blood cells, making this blood type uniquely compatible only with itself and posing challenges for safe blood transfusions.

Evaporative demand, also called **potential evapotranspiration** or **atmospheric thirst,** measures the atmosphere's ability to pull moisture from land and plants through evaporation and transpiration. It increases with high temperature, low humidity, strong winds and sunlight and prolonged high evaporative demand periods are known as **thirstwaves.**

The Strait of Hormuz is a narrow passage connecting the Persian Gulf to the Gulf of Oman and the Arabian Sea, lying between Iran and Oman.

The **World Economic Forum** releases the **Energy Transition Index** annually, which benchmarks **118 countries** on the performance of their current energy systems, emphasizing the shift toward a more **inclusive, sustainable and secure global energy future**.

Extreme Helium Stars are rare, low-mass supergiants made mostly of **helium** instead of hydrogen. Thought to form from the merger of a **carbon-oxygen white dwarf** with a **helium white dwarf**, 21 such stars have been found in our galaxy, with temperatures ranging from **8000 K to 35000 K**.

India's wind power has surpassed 51 GW, but infrastructural and policy

challenges pose a threat to renewable energy targets.

Quantum communication means sending information using tiny particles of light called photons. It is much safer than regular ways because it uses a special connection called **quantum entanglement**, where two particles stay linked even if they are very far apart. This makes the communication almost impossible to hack.

The "Decade Volcanoes" are 16 volcanoes identified by the International Association of Volcanology and Chemistry of the Earth's Interior (IAVCEI) as being particularly worthy of study due to their potential for dangerous eruptions and proximity to populated areas. These volcanoes were selected as part of the United Nations-sponsored International Decade for Natural Disaster Reduction in the 1990s.
