- Q.16 A tragic incident occurred at the Kalinga Institute of Industrial Technology (KIIT), Bhubaneswar, where a third-year B.Tech student from Nepal was found dead in her hostel room, suspected to have died by suicide. The incident led to widespread protests by Nepali students, alleging harassment and institutional neglect. They demanded a thorough investigation and the arrest of the accused.

In response, KIIT initially ordered all Nepali students to vacate the campus, leading to distress among them. While the administration later clarified its stance and attempted to restore normalcy, reports emerged of students facing forceful eviction, lack of support, and police intervention. The incident escalated into a diplomatic issue, with the Nepalese Prime Minister addressing the matter and diplomatic channels being activated to resolve it.

As an administrator handling this crisis, you are faced with multiple ethical dilemmas: ensuring justice for the deceased student, addressing the grievances of the protesting students, maintaining institutional stability, and navigating the diplomatic sensitivities between India and Nepal.

- (a) Identify the ethical issues involved in this case.
- (b) As an administrator, what steps would you take to balance justice, institutional discipline, and diplomatic relations?
- (c) How would you ensure the safety and emotional well-being of international students while upholding the rule of law?
- (d) What ethical principles should guide the actions of university authorities in managing such incidents?
- (e) How can institutions prevent such incidents in the future and foster a safe, inclusive, and accountable academic environment?

Ethics is constituted of moral principles that govern a person's behavior or the conduct of an activity. The aforementioned quote makes a differentiation between legal action (right to do) and ethical action, i.e., the right thing to do. For instance, 'right to protest' is a fundamental right derived from the right to free speech and expression and the right to assemble peacefully without arms as per the Indian Constitution.

However, this right to protest, agitate and demonstrate peacefully is often misused and exploited to block roads and highways, thereby causing hindrance to the general public. This shows that one's 'right' is not always exercised 'rightly'.

One can come across many such examples where rights exist, but there is a need to identify whether it is right or wrong to assert such a right. For instance,

- Exercising freedom of speech in such a way that it does not amount to defamation or sedition etc.
- Practicing religion in such a way that it does not disempower a gender or community.
- Giving up subsidies by people in case they do not need them any more for the benefit of those who need them.

The distinction between legal action and ethical action is paramount for all individuals in society. But it assumes greater significance for people in public office, as their actions have wider social and economic ramifications. For instance, a public official often grapples with this dilemma because not taking a legal action might be an ethical action.



For example, denying a needy person ration (food grains and other consumables) provided by the state due to lack of requisite official documents might pass the legal scrutiny, but it reflects poorly on the ethical conduct and conscience of the officer.

Conclusion:

However, people often have different and opposing ethical standards. Since ethics is developed from an individual's or a group's beliefs, values, and morals, it varies from person to person. Further, one person's ethical values can be in direct conflict and opposition to another person's values.

Therefore, societies adhere to certain common ethical standards, such as not lying, not stealing, respecting all religions, etc., as adherence to these standards ensures that the welfare of the society as a whole is not compromised.

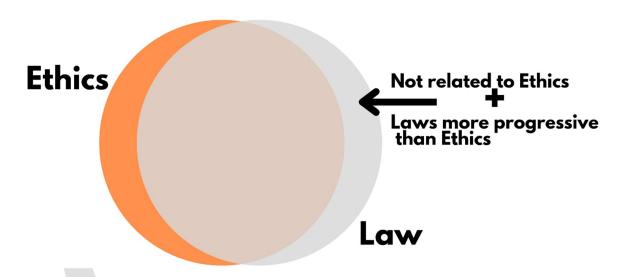

While laws can be defined as an assemblage of rules and regulations set up by legislative bodies that are indispensable and must be followed by the people, rules are the standard set of instructions to operationalise the law, which should be followed by public. Their purpose is to promote the common good and societal welfare as well as to protect individual rights.

However, laws and rules are not sufficient in themselves to guide public servants in certain situations as follows:

- **Conflicting laws:** In case of conflicting laws, a public servant's own moral prudence and individual morality rather than law serves as a guiding light.
 - For example, the conflict between sharing of information in the public domain through the RTI Act and restrictions as per the Official Secrets Act leads to the officer using his morality to decide the course of action on a case-by-case basis.
- Evolving laws: As the society evolves, it is not the laws and rules but larger public values and moral principles which serve as a source of ethical guidance for public administrators for bringing required changes in the laws and rules.
 - o For example, Section 377 of the Indian Penal Code, the Pre-Conception and Pre-Natal Diagnostic Techniques Act, etc.
- **Actions driven by compassion**: Owing to his compassion, a civil servant might have to go beyond the limiting laws to help a downtrodden or the needy.
 - For example, in case of an inclusion and exclusion error in the beneficiary registry, missing the Aadhar document, provisioning of ration to poor elderly who is a victim of the system and under desperate need.
- Sensitization and awareness: Public offices have Citizen Charters with specified rules guiding public services delivery, however, these rules are, at times, not followed due to lack of sensitization of public servants and awareness among citizens.
- Role of individual's conscience: At times, an individual's conscience helps as a guide to take ethical decisions.
 - For example, public administrators are involved in corruption cases despite the Prevention of Corruption Act, 1988.

Conclusion:

Beyond laws, rules and regulations, it is evident that public administrators must take reasonable care to ensure a clear inner conscience. Public administrators must not only do the right things but also do the things right.

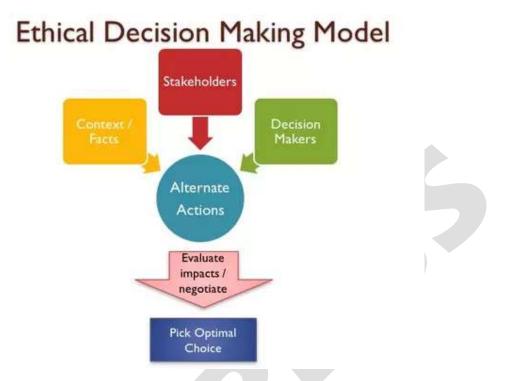

The state as the highest executive authority is required to perform administrative, legal, and regulatory functions. Broadly, state actions and policies need to conform with the constitution, laws, judicial pronouncements, international conventions and treaties. However, there isn't a necessary positive correlation between the legality of an outcome and its ethicality.





Body:

Depending upon the circumstances and requirements, views of different stakeholders may not be in consonance with each other. This is highlighted in the arguments given below:

- States reach out to all the stakeholders so as to include their interest in policies and programs.
 However, such outreach becomes difficult particularly when the interests of stakeholders are contradictory.
 - For e.g., labour reforms are viewed as promoting the interests of the employer at the cost of employees' interests.
- When it comes to significant areas such as national security or maintenance of law and order, the state cannot compromise with the fundamentals of the state.
 - o For e.g. state refusing refuge to immigrants to ensure national security.
- Sometimes, the state has to neglect the interests of a few in order to promote the larger interest of society.
 - For instance, infrastructure projects undertaken in the need for economic growth and development may cause tribal displacement.
- Resource constraint also hinders the state's ability to promote the common good and welfare. Therefore, it raises questions on the state policy of preferential treatment.
 - For e.g., development programs for minorities, SC/ST's etc.
- State policies to promote constitutional values could also hurt the sentiments of religious communities. The verdict in case of Triple Talaq law, Sabarimala case, Santhara/Sallekhana case etc. is viewed as state intervention in a matter of personal faith.

Conclusion:

State policies and actions must only be assessed in context of the requirements of the time and in light of them falling within the legal and constitutional framework. Needless to say that there should be a harmonious construction of the viewpoints of different stakeholders, so that conflicts can be resolved amicably.

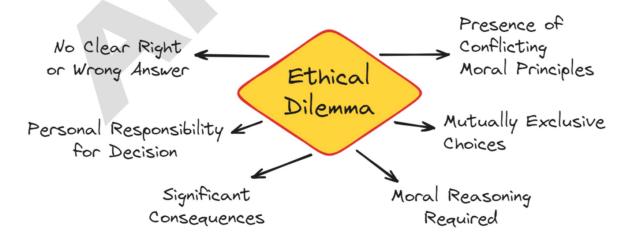
Introduction:

Conditions for Ethical Dilemma



This approach also upholds deontological ethics. Some of the rules and regulations for civil servants to overcome ethical dilemmas are the All-India Service (Conduct) Rules, 1968, the Central Civil Service (Conduct Rules), 1964, etc., which provide rules regarding acceptance of gifts by civil servants, etc.

Role of moral prudence in dealing with ethical dilemmas: Moral prudence is the ability to govern and discipline oneself by the use of moral reasoning.

It is a solution to a ethical dilemma in the following ways:

The concept of having an ethics officer was for the first time officially adopted in the USA in 1978. However, in the case of India, ethics officers are still a rarity. Even companies such as Tata Steel, which are known for their value system, do not appoint a separate ethics officer.

Their managing director is also the chief ethics officer. But, this is not a good practice since a CEO himself can be under scrutiny at times. The rising cases of unethical practices by corporates such as Vodafone, Ranbaxy and Apple, etc. highlights the need of ethics officers to strengthen the corporate governance further.

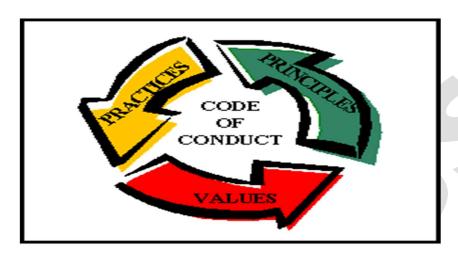

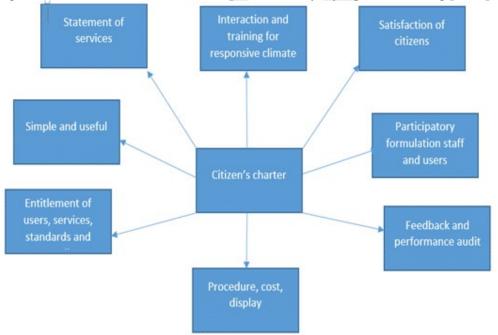

Thus, citizen charter has the potential to empower citizens and therefore in 1997, Union and state governments in India, decided to formulate citizens charter for sectors with large public interface - Railways, Telecom, Posts, Public Distribution Systems. These Charters were required to include standards of service and time limits that the public can reasonably expect, avenues of grievance redress and a provision for independent scrutiny with the involvement of citizen and consumer groups.

However, citizens charters in India have not yielded desired results and fell short of the expectations of empowering citizens due to the following reasons:

- As per various independent surveys conducted in India, it has been found that the consultation
 process with citizens and other stakeholders was minimal or largely absent. It thus became one of
 the routine activities of the organisation and had no focus.
- By and large service providers were not familiar with the philosophy, goals and main features of the Charter, since the set of the administrative staff/public officials who frame the charter are different from the one who implements it. Also, adequate training and sensitization programmes are not conducted within the departments.
- There is a lack of resources, as no funds have been specifically earmarked for awareness generation of Citizens' Charter or for orientation of staff on various components of the Charter. Also, no departmental level monitoring and evaluation is done to ensure the efficacy of the charter.

Conclusion:

For proper implementation of citizen charter to ensure citizen's empowerment, there is a need for citizens and staff to be consulted at every stage of formulation of the Charter, orientation of staff about the salient features and goals/ objectives of the Charter, need for wider publicity of the Charter through print media, social media and mass media, earmarking of specific budgets for it, and replication of best practices.
