Statement 2 is correct:

It is well-documented that agriculture employs the largest portion of India's workforce, while the services sector—despite contributing the most to GDP—employs a smaller share. For instance, services contribute about 60% of GDP but employ only around 25% of the workforce.

Statement 3 is correct:

The growth in services has often been termed "jobless growth" in the formal sector, leading to a rise in informal service sector employment.

The term "jobless growth" is widely used to describe the mismatch between GDP growth and formal job creation in India's service sector. Many studies highlight that much of the employment is informal or low-quality, as formal services are capital and skill-intensive.

Statement 4 is correct:

Digitalization and the rise of the IT/ITeS sector have further strengthened India's position as a global service hub, though the benefits are not evenly distributed across the workforce.

The IT and ITeS sectors have been major drivers of India's services exports and global reputation, but the benefits remain concentrated among skilled urban populations, with limited trickle-down effects.

4. Answer B

Explanation

Eastern Ghats Granulite Belt (EGGB)

The Eastern Ghats Granulite Belt (EGGB) is a Precambrian metamorphic terrain extending from northern Andhra Pradesh through Odisha into southern Jharkhand.

It mainly represents high-grade metamorphic rocks formed during the Proterozoic Era (2.5 billion to 541 million years ago).

These rocks were subjected to high temperature and pressure, giving rise to granulite facies metamorphism.

Major Rock Types in EGGB

Khondalite: A high-grade metamorphic rock rich in sillimanite and garnet, typical of Odisha and



named after the Khond tribe.

Charnockite: A type of granite containing orthopyroxene.

Migmatite: Mixed rock of metamorphic and igneous origin.

Anorthosite: Coarse-grained igneous rock containing plagioclase feldspar.

Alkaline rocks: Igneous rocks rich in sodium and potassium.

Thus, Assertion (A) correctly describes the composition and geological age of the Eastern Ghats region in Odisha.

Step 2: Relation to Mineralisation (Reason R)

The Eastern Ghats Granulite Belt hosts significant mineral deposits due to metamorphism and lateritic processes.

Major minerals found in these formations:

Bauxite - formed from weathering of khondalite and charnockite rocks.

Manganese - occurs in association with charnockitic rocks.

Graphite - found in khondalite and quartzite bands.

Gemstones (like garnet, sillimanite, kyanite) – occur in metamorphic formations.

Hence, Reason (R) is also true, since these rocks are indeed linked to mineralisation in Odisha.

Does R Explain A?

Assertion (A) talks about the geological composition and age of the Eastern Ghats Granulite Belt.

Reason (R) talks about economic mineralisation arising from these rocks.

While both are individually true, R does not explain why the EGGB represents the Proterozoic era; it simply provides an additional fact related to its mineral content.

5. Answer B

Explanation

The All India Depressed Classes Association was formed in Nagpur with M. C. Rajah as its first elected President. All-India Depressed Classes League was founded in 1935. It was an organisation dedicated for attaining equality for untouchables. Jagjivan Ram was instrumental in the foundation of the All-India Depressed Classes League. The All India Depressed Classes Congress was an organization founded by Dr. B.R. Ambedkar in 1930 after he resigned from the All India Depressed Classes Association. It was a political and social reform movement focused on securing political and social rights for the Depressed Classes (now known as Dalits), with a key goal of obtaining separate electorates for the community in legislative councils. The group's first session was held in 1930 and presided over by Ambedkar. Harijan Sevak Sangh, formerly All India Anti Untouchability League, is a non-profit organisation founded by Mahatma Gandhi in 1932 to eradicate untouchability in India, working for Harijan or Dalit people and upliftment of Depressed Class of India.

6. Answer A

The Ganjam plates of Madhav Raja II (a ruler of the Shailodbhava dynasty) are important epigraphic sources for early medieval Odisha. These copper plate inscriptions provide detailed information about: The genealogy of the Shailodbhava rulers, Their territorial extent and political control, and The administrative divisions under their rule.

They do not deal with maritime trade, temple construction, or diplomatic relations with the Gupta Empire.

The Siwalik range or Sub-Himalayas form the outermost foothills of the Himalayas. They are made up of Tertiary/Neogene molasse deposits — sandstones, conglomerates, siltstones — which are relatively young, often unconsolidated or less cemented, forming the low hills/foothills before the plains.
